Article V, Section 5.03 of the Bylaws of S.A. Heritage Condominiums at Coppertree Owners Association, Inc., are hereby amended as follows:

I.

5.03. The presence, either in person or by proxy, at any meeting, of members entitled to cast at least ten percent (10%) of the total voting power of the Association shall constitute a quorum, except as otherwise provided in the governing instruments. In the absence of a quorum at a meeting of the members, a majority of those members present in person or by proxy may adjourn the meeting to a time not less than five days or no more than thirty days from the meeting date.

The foregoing amendment was adopted by the Board of Directors of S.A. Heritage Condominiums at Coppertree Owners Association, Inc., a duly called meeting at which a quorum was present, or by signed, unanimous written consent in lieu of a meeting, as certified by the signature of the President and Secretary of the Association below.


